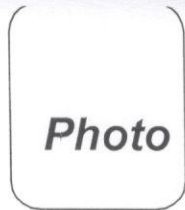
- (i) The qualification for Guest/Part time teacher should be same as those prescribed for the regular teachers of University in UGC regulation.
