3. Candidates who have appeared in "Ph.D. Law Entrance Examination" June, 2018, University of Delhi and have secured not less than 50% marks i.e. 100 marks & those in reserve categories not less than 45% marks (90/200) in the Entrance Examination.
4. Teachers in the service of University of Delhi.

- (iii) Literature Survey
- (iv) Hypotheses
- (v) Operational Definitions
- (vi) Aims and Objectives of Study
- (vii) Research Questions

- (ix) Limitations of Study
- (x) Tentative Chapterization

It is mandatory that candidates submitting their synopsis should consult a faculty member to guide him/her for developing the synopsis/research design. For any other information, please contact the office of Dean, Faculty of Law.

The Departmental Research Committee is likely to be held at the end of February, 2019 or 1st week of March, 2019.

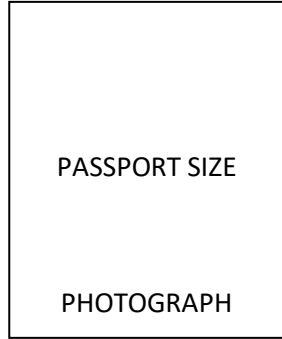
