Re-Admission in LL.B. III/V Semester for the Academic Year 2025-26

All the students of the CLC (including ***detained*** in LL.B. IIIrd / Vth in previous academic year / those who were ***Absent or ER in LB-501 (Moot Court Exercise and Internship)*** in the earlier semester), are hereby informed that re-admission in LL.B. IIIrd / Vth Semester for the Academic Year 2025-26 has started w.e.f. 21.07.2025. The students are required to fill re-admission form (as provided below). The Re-admission forms are required to be submitted physically in the CLC office **between 10:00 AM - 12:30 PM & 02:00 PM - 03:30 PM** (Except Saturday and Sunday) for verification.

The Last date of submission of Re-Admission form is 28.07.2025.

Students who have cleared a minimum of 05 papers for IIIrd Semester and 15 papers for Vth Semester based on their results in Semester examination

are required to submit their **re-admission form** along with supporting documents mention below in CLC office for verification:

1. All semester marksheets (I/II/III/IV) with copy of last attended Admit Card –self attested.
2. Duly Filled Admission form. (Optional Subjects mentioned below this notice)
