PhD Phase-I Admissions, 2023-24

Eligibility under Phase - I of PhD Admission:

All candidates who are exempted from the entrance examination as per the University of Delhi Ordinance VI dated August 9, 2017 [*Procedure for Award of Master of Philosophy (MPhil) and Doctor of Philosophy (PhD) Degree*] and *bulletin of information for admission to Ph.D programs for Academic session 2023-24* are eligible for the interview, provided they have **applied already through the University admission portal and uploaded relevant documents and research proposal in accordance with this notification.**

Research Proposal and Document:


All candidates who have applied for the PhD Program on the portal under Phase-I must submit hard copy of their research proposals, copy of the online application for PhD Admissions 2023, and other relevant valid documents (qualifications, caste/category specific certificates, document indicating exemption from entrance, etc.) **by Thursday, 31st August 2023** in the Office of Dean, Faculty of Law and soft copies also using the email id **phdadmission2023@du.ac.in**.

Every Synopsis of Research Proposal (Not exceeding 10 pages should contain the following:

- (i) Title of the Research Proposal
- (ii) Statement of the Problem
- (iii) Literature Survey
- (iv) Research Gaps
- (v) Objectives of the Study
- (vi) Research Questions
- (vii) Hypothesis
- (viii) Research Methodology
- (ix) Scope & Limitation of Study
- (x) Tentative Chapterization

Five (05) Hard Copies of Synopsis of Research Proposal along with Form (attached below) and relevant valid self-attested documents are mandatory to be submitted in the Office of Dean, Faculty of Law.

The Departmental Research Committee is likely to be held shortly.

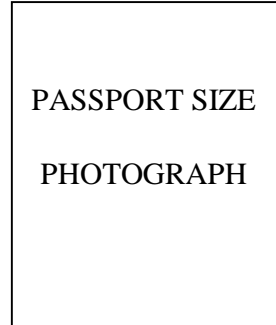
