- 1. The following course content should not be treated as exhaustive. The questions may be set from any topic which the examiner feels relevant to the subject.
- 2. There shall be one written examination of three hours' duration in each subject at the end of each Term. One question paper shall be set in each of the subjects prescribed for study and examination. Each paper shall carry 100 marks. The minimum pass marks in each subject shall be 50%.
- 3. Every student of this course is required to present a paper in the class for discussion on a topic assigned by the concerned teacher. No student shall be permitted to appear in the examination unless a certificate is issued by the teacher that the paper presented by the student was to his/her satisfaction.

#### **OBJECTIVE**

The objective of this course is to understand and analyse the growth and development of International Organizations (IOs) and particularly that of the United Nations. It provides the ways how these organizations have contributed to the growth and development of international law relevant for the purposes of regulating and facilitating the inter-state relations of member countries. This course also focuses on important basic aspects of international organizations such as powers, functions, privileges, immunities and responsibilities of international organizations with a special emphasis on the United Nations. This course is designed to study and analyse the institutional mechanism for protection and promotion of human rights with a special focus on human rights bodies under the United Nations Charter and certain specific human rights treaties.
