

- Provide a collaborative platform for lawyers to share documents securely and communicate with needy ones in real-time, facilitating teamwork.

## OUR KEY FOCUS AREAS

Our organization actively works towards strengthening Access to Justice, with a focus on promoting legal awareness and community empowerment. Our core focus areas include:

**Legal Literacy & Legal Awareness** - Conducting awareness programs to educate communities about their legal rights, duties, and available remedies.

**Legal Aid & Access to Justice** - Providing guidance, support, and assistance to ensure that marginalized and vulnerable individuals are able to effectively access justice.

**Mental Health Support** – Promoting mental well-being and providing basic counseling support to individuals facing legal and social challenges.

**Research & Documentation** - Undertaking field documentation, case studies, and data collection to support evidence-based legal interventions, policy advocacy, and informed decision-making.

# PROJECT SAKSHAM 1.0, 2.0 & 3.0

**Project Saksham 1.0** was an initiative by the Nek Mission Foundation from **September 2022 to December 2022**. It was in collaboration with the Central District Legal Services Authority and many other agencies. The project focused on 5 specific areas, with 10 teams assigned to conduct 50 Ground visits covering 6248 houses. The project successfully touched and made a difference in the lives of 28,745 people.

**Project Saksham 2.0** was a collaborative initiative involving Law Centre 1, Law Centre 2 of the Faculty of Law, University of Delhi, Indraprastha University, Jamia Hamdard University, Nek Mission Foundation and Naksh Foundation from **2 May 2023 to**

**5 December 2023**. Project Saksham 2.0 was an expanded phase of the Project Saksham initiative, implemented by Nek Mission Foundation with the objective of strengthening legal awareness and access to free legal aid for underprivileged and unserved communities. The project focused on identifying and addressing common legal and social issues such as lack of awareness about free legal services, documentation problems related to Aadhaar cards, E-Shram cards, senior citizen cards , pension card, labour welfare, and other covered by various government schemes.

Through extensive door-to-door surveys, 144 ground visits, and the organization of 12 mega camps, Project Saksham 2.0 provided legal consultations, documentation assistance, health support, and educational outreach across multiple areas.



The initiative successfully reached 77,860 people, covering 25,920 households, and addressed hundreds of legal cases, thereby contributing significantly to legal empowerment and social justice for women, children, senior citizens, labourers, LGBTQ+ persons, and other vulnerable sections of society.

**Project Saksham 3.0** was a nationwide legal literacy and legal aid initiative conducted from June 2024 to April 2025 under the Alumnus Initiative of the Faculty of Law, University of Delhi, under the aegis of the Nek Mission Foundation. Implemented across six states through 76 teams and nearly 1,200 volunteers, the project covered 38 areas, surveyed 32,400+ households, and impacted over 1.2 lakh people. It provided free legal aid, handled 700+ legal cases, organized 28 mega camps, and conducted seminars, webinars, workshops, moot court competitions, and POCSO and cyber law trainings. The initiative focused on empowering women, children, senior citizens, labourers, persons with disabilities, LGBTQ+ individuals, and other vulnerable groups, strengthening access to justice and legal awareness at the grassroots level.



# TARGET BENEFICIARIES



Project Saksham is dedicated to supporting individuals and communities who are most vulnerable and often face barriers in accessing justice, awareness, and social support. The initiative primarily focuses on women, children, persons belonging to Scheduled Castes and Scheduled Tribes, persons with disabilities, victims of trafficking, and victims affected by disasters or social conflict. It also extends support to industrial workers, persons in custody, and individuals from economically weaker sections with an annual income below ₹3 lakhs. Through legal awareness, guidance, and community-based initiatives, Project Saksham aims to empower these groups, protect their rights, and help them access justice and opportunities for a dignified life.

# METHODOLOGY

## SAMPLING TECHNIQUE

Door-to-door outreach is conducted through mapped ward/colony clusters using a fixed route plan to ensure broad, non-selective coverage across **33 cities in 11 states**. Priority inclusion is ensured for vulnerable groups (women, children, senior citizens, persons with disabilities, migrants, informal workers, deprived sections).

## FIELD OUTREACH PLAN

Teams deliver brief legal literacy messages, identify issues/grievances, provide basic guidance on rights and procedures, and generate referrals to appropriate authorities/legal services. Each visit follows a standard workflow:

**introduce → consent → awareness → case intake/referral → follow-up schedule.**

## DATA ACCURACY

A standard questionnaire/case-intake format is used across all locations, with unique IDs for each household/case. Team leads perform daily review, random back-checks, and cross-verification (call-back/second visit or document check where voluntarily shared) to maintain reliability.

## PRIVACY & CONFIDENTIALITY

Participation is voluntary with clear consent, and only minimum necessary information is collected. Identifiers are restricted to authorised team members, and reporting is anonymised/aggregated to protect confidentiality and community trust.

## Level 4

### THE EXECUTION LAYER

#### State Coordinators

Senior students or research scholars are responsible for supervising the state-level implementation of Project Saksham 4.0 and coordinating with all participating colleges within the state.

#### Student Convenors (2 per College)

They manage and coordinate all Project Saksham-related affairs within their respective institutions. They also act as Field Coordinators, responsible for managing volunteer rosters, local logistics, and the day-to-day operations of the Satellite Clinic.

#### Task Leads

Students are assigned to lead specific functional areas such as Media and Public Relations, Field Surveys, and Event Management.

## Level 5

### THE VOLUNTEER LAYER

#### Justice Mitra

A group of 50–100 selected Law students from each partner university.

#### Functional Groups

- **Group A (Legal Awareness):** Conducts mega legal awareness camps and door-to-door legal literacy drives.
- **Group B (Legal Advocacy):** Organizes seminars, workshops, and awareness sessions in schools and colleges.
- **Group C (Legal Aid):** Operates the Satellite Legal Clinics and manages case intake and initial documentation, with support from the Legal Wing.

The General Compliance Committee ensures adherence to organizational ethics, statutory obligations, and professional conduct.


