Government of Gujarat had given him the second term of Vice Chancellor, Maharaja Sayajirao University of Baroda, which he continued up till December 29, 2014.

He received his M.Tech. (Electronics & Communication Engineering) and Ph.D. (Computer Engineering) degrees from National Institute of Technology, Kurukshetra, Haryana. He has supervised 23 Ph.Ds in the area of Software Engineering. He has more than 250 publications in International and National Journals/Conferences.

He wrote a book on "Software Testing" published by Cambridge University Press, England (2011). He has also co-authored books on Software Engineering published by New Age International Delhi (2002), and Object Oriented Software Engineering published by PHI Learning, Delhi (2012). Prof. Yogesh Singh participated in YALE-INDIA LEADERSHIP PROGRAMME in Yale University, USA (2011).

He is a member of the Executive Committee of National Assessment and Accreditation Council (NAAC) with effect from October 03, 2019. He is also an independent Director of Gujarat State Petro Net Ltd. and Gujarat State Petroleum Corporations Ltd. (Government of Gujarat Undertakings) since May, 2013 and March, 2015 respectively. He is appointed as the Additional Director (Non-Executive, Independent Director) on the Board of Director of Gujarat Gas for the tenure of 5 years w.e.f. from 15 August, 2021.

As a national expert, she contributed to the World Bank's Report in 2017 on the subject, "Enabling the Business of Agriculture, - Access to Water". Her critically acclaimed projects include the country report for the International Research Project on "Climate Change Commitments: An Ethical Analysis" conducted by the University of Auckland, NZ and Widner University, USA with support from IUCN World Commission on Environmental Law and its specialist Ethics Group in October 2015 as well as research projects sanctioned by the University Grants Commission, Delhi, National Commission for Women, Delhi and the University of Delhi.
