The applications shall be submitted in the prescribed form (Annexure "1").


The application shall bear the recent passport size photograph of the applicant. The application shall be submitted by post **only** in a closed envelope, clearly mentioning on the envelope "**Application for appointment as Law Researcher at Delhi Judicial Academy**", addressed to the **Director (Administration), Delhi Judicial Academy, Sector-14, Dwarka, New Delhi-110078**. The application should reach the Academy on or before **04.08.2024** by 4:00 p.m.

Applications which are incomplete, unsigned and received after prescribed date and time, shall be rejected summarily and no enquiry will be entertained in this regard.

Shortlisted candidates will be called for an Interview which will comprise 100 Marks. Interview dates will be intimated telephonically/ e-mail later on.

It may also be noted that the above engagement is purely contractual in nature. It would not confer any right of permanent employment at Delhi Judicial Academy. It is also clarified that a Law Researcher will not be entitled to pursue further studies or practice or take up any other assignments during the period she/he works as Law Researcher at the Academy.
