- (7) that I am aware that no student of LL.M./M.C.L. shall be deemed to have pursued a regular course of study unless he/she has attended a minimum of two-thirds of total number of lectures delivered in each course of the Term in which he/she has been admitted as a regular student and he/she has submitted term paper for class discussion in each course and the teacher teaching the course is satisfied with the paper and its presentation in the class;
- (8) that on admission to the Course of Study for which I have made this application, I submit myself to the disciplinary jurisdiction of the Vice-Chancellor and several authorities of the University who may be vested with the authority to exercise discipline under the Act, the Statutes, the Ordinances and the Rules that have been framed or may be framed from time to time by the University in this respect.
